

In exercise of the powers conferred by sub-section (5) of section 8 of the Central Sales Tax Act, 1956 (Central Act No.74 of 1956), the State Government being of the opinion that it is expedient in the public interest so to do, hereby directs that the tax payable under the Act on the sale of goods manufactured by the unit(s) approved by the State Level Screening Committee as constituted under the Rajasthan Investment Promotion Scheme, 2003 and established by the Japanese Investors affiliated to Japan External Trade Organization, in the Japanese Zone developed by RIICO as explained hereunder, shall be calculated at the rate of 0.25% on furnishing of declaration in Form 'C'.

Explanation: Japanese Zone means the new industrial units complex Mazarkath, Neemrana located at National Highway No. 8 at 121 KM Stone from Delhi on East Side of Highway, developed by RIICO, covering an area of 1167 acres.


