

**OFFICE ORDER (06/2020)**

**Sub: Partial amendment in the existing provision of the Rule 3(H-1) of RIICO Disposal of Land Rules, 1979 related to preferential allotment of land to Departments/ Undertakings/ Organizations of the Rajasthan State Government for industrial purpose so as to incorporate Departments/ Undertakings/ Organizations of Central Government also.**

An agenda was placed before the IDC vide item (16) in its meeting held on 30.12.2019 and the IDC has accorded approval for partial amendment in the provision of Rule 3 (H-1) as under:
