**Reg : Dearness Allowance**

Consequent upon the order .No. F.6(3)FD(Rules)2017, Jaipur dated 27.03.2020 received from Finance Department, GOR, Jaipur, the existing rate of Dearness Allowance(DA) i.e. 12% in terms of office order No. RFC/PA-22(20)/1957 dated 05.03.2019 payable to the employees of the Corporation drawing pay in Rajasthan Financial Corporation Staff (Revised pay scales), Rules, 2017 shall be revised from 12% to 17% w.e.f. 01.07.2019 with the following stipulations:-

1. The term "Pay" for the purpose of calculation of Dearness Allowance shall be the Basic Pay i.e. pay drawn in the Pay Matrix of the prescribed Levels and shall not include any other type(s) of pay like special pay or personal pay etc.
2. The payment on account of Dearness Allowance involving fraction of 50 paisa and above may be rounded off to the next higher rupee and the fraction of less than 50 paisa may be ignored.
3. For the Corporation employees, the above increase of DA installment @ 5% shall be paid from the salary for the month of April,2020. Arrear of increase amount of DA for the period from 1.7.2019 to 31.3.2020 shall be paid in cash.
4. For the officials who are on deputation from the State Government etc. into the Corporation, the above increase in Dearness Allowance for the period from 01.07.2019 to 29.02.2020 shall be credited to General Provident Account of the respected employees and cash payment shall be admissible from 1.03.2020 i.e. salary for the month of March,2020 payable on 01.04.2020 as per State Government order No. F.6(3)FD(Rules)2017 dated 27.03.2020.

1. Out of 61% dearness allowance sanctioned vide office order No. RFC/PA-22(20)/762 dated 07/09.06.2004, 50% dearness allowance has been treated as Dearness Pay w.e.f. 1.7.2004 as per office order No. RFC/PA-23(5)/1101 dated 13.07.2004.
2. The above increased amount of DA installment @ 17% shall be paid from the salary for the month of April,2020 and arrear of increased amount of DA for the period from 01.07.2019 to 31.03.2020 shall be paid in cash to the Corporation's employees who are drawing pay in RFC Staff (Revised pay scales) Rules,1998.
3. The term "Pay" for the purpose of calculation of Dearness Allowance shall be the pay as defined in Regulation No. 3(d) (i) of Chapter 1 of RF Staff Regulations, 1958 which is drawn in the prescribed RFC Staff (Revised pay scales), Rules, 1998 and shall not include any other type(s) of pay like special pay, personal pay etc.

The above increased amount of DA installment @ 10% shall be paid from the salary for the month of April,2020 and arrear of increased amount of DA for the period from 1.7.2019 to 31.03.2020 shall be paid in cash to the Corporation's employees who are drawing pay in RFC Staff (Revised pay scales) Rules,2008.
