Remaining part of the premium will be borne by the Corporation.</p> <p>Subscription as per Office order no F1(258)RGHS/SAB/2021-22/653 dated 03.08.2021, issued by State Insurance and Provident Fund, GoR is Rs.6100/- per annum. Office order no F5(5)FD/Insurance/2020 Part-II dated 07.07.2021 issued by Finance (Insurance) Department, GoR has fixed subscription rate for employees appointed on or after 01.01.2004 as under:</p>

This option will not be available for employees retiring after cut off date i.e. 28.02.2022.</p>
